4th Of July Pet Safety Tips

Ensure your dog gets plenty of exercise during the day and keep them inside during fireworks.

Lower blinds and close windows so they wont be frightened by the noise and bright lights.

Provide a safe place for them to retreat like their crate or bed and check on them every few hours.

- If your dog must be outside, make sure it has a collar and ID tag, and if you have a GPS pet locator, make sure it is fully charged.
- Keep alcohol, matches, citronella candles, bug sprays, sunscreens and lighter fluid out of your dog's reach.
- Ask guests to please avoid feeding your dog people food. Foods such as onions, chocolate, coffee, avocado, grapes & raisins, salt and yeast dough can all be potentially toxic to our furry friends.


Fireworks 101

Are you planning a pyrotechnic masterpiece for your friends and family this year? Make sure you know what is legal in your area first. Delaware, Massachusetts, and New Jersey have banned all consumer fireworks. Illinois, Iowa, Ohio, and Vermont allow only Sparklers, trick noisemakers & novelties. 43 states plus the District of Columbia allow some or all types of consumer fireworks permitted by federal regulations. Laws vary by state, so before you plan please consult the Directory at www.americanpyro.com.

Leaves Of Three...

I'm sure you've heard the saying "Leaves of three, let them be" but did you know a poison ivy plant's appearance may vary depending on location? Some can have groups of five, seven or even nine leaves.

According to the American Skin Association, **about 85% of the population is allergic** to poison ivy, poison oak or poison

sumac and it is the most common allergic reaction in the U.S., affecting as many as 50 million Americans each year. It is very easily spread and you don't need

to actually touch the plant itself to be exposed. You can develop a rash from the poison plant oil left on clothing, pets, garden tools, and other items that have come in contact with these

that have come in contact with these plants. The oil lingers (sometimes for years) on

any surface until it's washed off with water or rubbing alcohol.

If you suspect you have come into contact with a poison plant, wash yourself immediately with COLD water. Remove your clothing as soon as you're able and take a shower with WARM WATER. Wash your clothing and other items with HOT water.

Trivia Answers: The first bank card, named "Charg-It" was introduced in 1946 by John Biggins, a banker in Brooklyn. A customer could use the card to make a purchase and the bill was forwarded to Biggins' bank which reimbursed the merchant and obtained payment from the customer.



The **Diners Club Card** claims the title of first <u>credit card</u> in widespread use. According to a Diners Club rep, in 1949 Frank McNamara forgot his wallet during a business dinner in

New York's Major's Cabin Grill and decided there should be an alternative to cash. McNamara and his partner, Ralph Schneider, returned to the restaurant in February of 1950 and paid the bill with a small, cardboard card they called The Diners Club Card. By 1951 there were 20,000 Diners Club cardholders.

They based their decision on a 1992 Supreme Court ruling in *Dewsnup v. Timm* that held that a first mortgage cannot be stripped down to the current value of the property.
